

Welcome Great Lakes Advocates

On behalf of the Governance Board, members, and staff of the Healing Our Waters–Great Lakes Coalition, I am pleased to welcome you to Cleveland for our 2023 Great Lakes Conference. After a shorter in-person conference last year following two years of virtual conferences, we are excited to expand our time together into two full days. Plenaries and breakout sessions will cover both days, and we're offering the addition of optional field trips and an evening reception on the first day.

This year has been a time of reflection as we look at what progress has been made, what remains to be done, and what has been missed in the Great Lakes restoration effort that was launched nearly 20 years ago by the Great Lakes Regional Collaborative Strategy to Restore and Protect the Great Lakes, spawning the Great Lakes Restoration Initiative (GLRI) and other programs.

After big legislative wins during the 117th Congress and facing tough political headwinds, we focused efforts this year to create a set of recommendations for the next Action Plan of the GLRI, which guides the EPA and other federal agencies in directing GLRI investments. In general, the recommendations were related to three areas: 1) strengthening the capacity of historically underserved communities so that they can participate in decision making, collaboratives, workforce development, job training, and other efforts to help communities address climate change and prepare for the climate impacts we know are coming; 2) investing in tools for projects in communities most impacted by pollution and environmental harm; and 3) advancing adaptive projects that will keep up the momentum for public, economic, and ecological health.

We believe that these recommendations respond to the threats that the Great Lakes face today and in the future. These recommendations were not created in a vacuum; every step of the way we engaged with our partners across the Great Lakes region, from community-based organizations to large regional groups. We hosted a series of sessions for our partners to give feedback on our draft recommendations, recognizing that a restoration agenda for the Great Lakes needs to include everyone in the region, especially the communities that have been left out of the conversation over the years.

While we know that pollution, environmental harm, and climate change are devastating to ecosystems, we also know that these threats are devastating to communities and to people. In the past, traditional restoration activities have not always acknowledged the serious impacts to communities, and therefore have not prioritized actions that benefited the communities most impacted by pollution and harm. In our ongoing federal policy work, we aim to push for a more holistic and inclusive approach to restoration, highlighting the social and community needs, as well as the physical and environmental ones. Restoration needs to be about people, planet, and wildlife, and the Coalition is committed to leading all of our work with that as our framework.

Finally, I want to thank all of you. Whether you're a longtime partner, a new Coalition member, or this is your first interaction with the Coalition, thank you for coming into this space with us. I hope you leave the conference feeling energized with new information, inspiration, and connections with fellow advocates.

We look forward to getting to know all of you and further building on our collective commitment to Great Lakes restoration and protection for all who call this region home.

GREAT LAKES GREEN EVENT

The 2023 Great Lakes Conference is the first official Great Lakes Green Event! This regional initiative from the Great Lakes St. Lawrence Governors and Premiers encourages destination stewardship and environmentally beneficial practices for conferences and other events in the Great Lakes St. Lawrence region. Host organizations are encouraged to adopt practices like reducing food waste and eliminating single-use plastic bottles at their events.

The initiative also supports tree planting in the host city due to the multiple environmental benefits of trees, such as storing carbon, absorbing stormwater, and improving the health of streams and lakes, as well as public health benefits like reducing urban heat effects, providing shade, and improving local air quality. A tree planting ceremony with Governor DeWine and other dignitaries is planned for Friday, October 13 at 2:45 PM at Cleveland's Great Lakes Science Center, in partnership with the Western Reserve Land Conservancy and the Cleveland Trees Coalition.

Fun Fact: An avid baseball fan, Alexis is aiming to go to every MLB park and has hit 4 in the past year.




SOPHEE LANGERMAN, EQUITY AND JUSTICE PARTNERSHIPS COORDINATOR




LINDSEY BACIGAL, COMMUNICATIONS COORDINATOR


